Grant schemes – local funds

Landfill Communities Fund

Not-for-profit organisations operating near waste processing and recycling sites may be able to apply for grants from this Fund. The exact conditions and grant amounts vary from scheme to scheme, but several community buildings in Hampshire have been awarded sums of £20,000 or more. Apply soon because these schemes are due to close in the next year or two (Viridor is closing in our area on 10 July 2017).

Funding for building works (repairs, extensions and refurbishments) and equipment directly linked with a community building; e.g. stage lighting or sound systems. Grants of up to £25,000 (increased from £15,000), at least 50% match funding required.

Each County Councillor has funding to award to local groups and organisations for activities that fit one or more of the Council's corporate priorities.

Your borough / district and parish council

Some councils have reduced or stopped their funding programmes for not-for-profit organisations so check your local situation. You may also be able to ask your parish council for funds directly or via the [Public Works Loan Board](#).

Section 106 Developers' Contributions / Community Infrastructure Levy

These are levied on new building developments, and community buildings may be able to obtain funds for improving their facilities. Contact your parish council in the first instance, or your district / borough council (who actually hold the funds).

New Forest National Park grants

South Downs Sustainable Communities Fund

Funding for projects that bring 'social, environmental, economic or cultural benefits to a community within the National Park'. Grants of £250-£10,000 are available, covering up to 50% of the total project cost. (Work on community buildings is not currently eligible.)

LEADER

Most parts of rural Hampshire are within an area running LEADER, which is aimed at 'creating wealth in rural areas'. You must be very clear about how the local community will benefit (in economic terms) from the work for which you are seeking funds.

Loans from £1,000 to £20,000 (and occasionally higher) to help community halls in rural areas to meet the cost of capital works. The Fund is often over-subscribed so please contact ACRE as soon as you decide that you might want to apply for a loan.

Loans of at least £250,000 for not-for-profit organisations working in any social sector, but focused on improving the well-being of vulnerable and disadvantaged people.

Local solicitors and churches

Some solicitors and churches (especially Church of England) run funds focusing on small geographical areas. These aren't often advertised widely but may be able to fund your work.

Local businesses

They may be able to help with grants, sponsorship (in return for some publicity), resources, equipment, staff time etc. Be creative with what you can offer local companies in return for their support and use any contacts or other links you have.

Crowdfunding

This is a new approach to fundraising which uses online technology to enable the gaining and handling of donations from a large number of people.

It is also well worth keeping in touch with every level of Local Authority that covers your area – e.g. for rural Hampshire this means Hampshire County Council, your district / borough council, and your parish / town council.

Get to know your elected members (councillors), and find out who the key officers are for issues like planning, licensing, funding, and community development.
